ACT 1 is an entry level test that is open to all dogs that have not earned a title in any AKC Agility class. Dogs must have two passing ACT 1 scores in order to earn the ACT 1 title. Both passing scores may be obtained under the same judge/evaluator. To receive the title certificate and have the title added to a dog's record, the dog must be registered/listed with the AKC.

ACT 2 is the second level Agility Course Test that is open to all dogs that have not earned a title in any AKC Agility class except an ACT 1 title. Dogs must have two passing ACT 2 scores in order to earn the ACT 2 title. Both passing scores may be obtained under the same judge/evaluator. To receive the title certificate and have the title added to a dog's record, the dog must be registered/listed with the AKC. The ACT 2 title will supersede the ACT 1 title on a dog's record.

REFUNDS:

Refund requests received prior to the close of entries will be charged a \$5.00 per day processing fee. After the close of entries, refunds minus a \$10.00 per day processing fee may be allowed on a case-by-case basis (bitch in season or an injury to your dog would be valid reasons to request a refund) if a request is made via email to Jen@MatrixDog.com by 6pm on Friday April 6, 2018. No refunds after 6pm on Friday April 6, 2018.

HEIGHT DIVISIONS:

For the ACT Program dogs may participate at any jump height which is determined by the owner. There is no Regular/Preferred split for ACTs.

AWARDS:

A dark green <u>qualifying ribbon</u> will be available to all qualifying dogs. A <u>title ribbon</u> will be available to all dogs achieving a new title. *All ribbons must be claimed the day of the trial. None will be mailed.*

COURSE FAMILIARIZATION:

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only.
A warm-up area, consisting of a regulation agility jump, will be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training the dog.

OBSTACLES & TIMING:

Obstacles will meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. This trial will be held indoors on mats with ring dimensions of approx. 70' x 50'. Timing will be done with a stopwatch.

ACT 1 is 10-12 obstacles and consists of the a-frame, pause table, open tunnel(s), bar jumps, and MAY also use the panel jump, and/or tire jump.

ACT 2 is 11-13 obstacles and consists of the a-frame, teeter, pause table, weave poles (6), open tunnel(s), tire jump, bar jumps, and MAY use the dog walk, double bar jump, panel jump, broad jump, and/or triple bar jump.

RINGSIDE:

Dogs may arrive any time prior to judging. Judges are not required to wait for dogs. The owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required. No refunds will be issued for absent or late dogs.

PARKING:

Exhibitors are governed by any rules or regulations of civic authorized and building and parking regulations. Vehicles parked contrary to regulations will be subject to towing at owner's expense.

RV/OVERSIZED VEHICLE PARKING:

RV's and oversized vehicles (taking up more than one parking space) are allowed – please contact us with specs for more information on where to park. Parking overnight is allowed at your own risk. No hook-ups are available.

ELIGIBILITY OF DOGS:

All dogs fifteen (15) months of age or older may enter a test. Dogs must be physically sound as described in Chapter 1, Section 3, Paragraph 7 of the Regulations for Agility Trials. In order to acquire the title certificate and have the title added to a dog's record, the dog must be registered/listed with the AKC. Canine Partner applications may be accepted at the test by the judge/evaluator and submitted with test results. Dogs that are not AKC registered/listed may participate and their performance will be recorded by the AKC under a temporary recording number. This temporary recording number will be e-mailed to the owner and must be used when entering subsequent ACT events and when the owner registers/lists the dog.

Note: Temporary recording numbers may only be used to enter ACT events.

Dogs should be physically sound. Dogs that are blind or deaf shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dogs shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes.

ROUTES TO THE TRIAL SITE: 3905 Fairview Drive, Carson City NV 89701

<u>Coming from the East on US 50</u>: Head South (left) on Fairview Drive. At 0.9 miles, turn left onto Lepire Drive to access the parking lot. The building is on the Southeast corner of Fairview Drive and Lepire Drive.

<u>Coming from the West on US 50</u>: Exit Fairview Drive and turn to the right. The building is the first building on the right after the round-about. You'll turn right onto Lepire Drive to access the parking lot. The building is on the SE corner of Fairview Drive and Lepire Drive.

<u>Coming from the North (Reno)</u>: Take 580/395 to College Pkwy. Turn left onto College Pkwy. College Pkwy turns into Fairview Drive as it crosses US 50/Williams. After crossing US 50/Williams, go 0.9 miles and turn left onto Lepire Drive to access the parking lot. The building is on the Southeast corner of Fairview Drive and Lepire Drive.

EXHIBITOR INFORMATION:

SAFETY, BEHAVIOR and LIABILITY

In such case, no refund of any fees paid will be made.

I (we) acknowledge that if this application for the entry of this dog is made available to me (us) for participation in this event, that I (we) agree that this facility/club has the right to refuse the entry of this dog and/or they reserve the right to dismiss the dog and myself for cause which the facility/club deems to be sufficient. In consideration of the acceptance of this and the opportunity to train my dog(s), I (we) agree to hold American Kennel Club, Matrix Dog, LLC, Dog Sports America and all associates harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog or dogs while in or upon the premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for such claim, and I (we) further agree to hold the aforementioned parties harmless from any claim for damage or injury to the dog or myself, either physically or mentally, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by negligence while in or upon the premises of the trial grounds. Dogs that are not AKC registered/listed may be registered at a later date and receive their ACT title at that time.

Dogs listed in the AKC Canine Partners[™] program should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler Number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
